## IV. PROJECT PROPOSALS

Funding is a key component of an organization, and a lot of time and energy has been dedicated to search funding. We will present 3 categories of project proposals:

### 4.1. Successful Proposals-Terminated projects

**Thematic Mission to the ONSTAGE Urbact Thematic Network.** The [URBACT](#)



[program](#) is the program of the European Union dedicated to urban Sustainable Development. The municipalities of L'Hospitaliet de Llobregat in Spain, Grigny in France, Valdero Portugal, Adelfia in Italy, Aarhus in Denmark and Katowicze in Poland have joined forces to exchange on the role of music schools in the social inclusion of vulnerable groups. With 43% of Youngsters unemployment, the town of Grigny is a city with sensitive problematics within the Ile de



France region (vulnerable group, suburban physical environment). The role of Pilot4dev has been to support the town of Grigny to draft their

Action plan and roadmap in implementing the project. The reports of the mission are available upon request



**The Meru cultural Centre in Tanzania** has been a pilot for our organization, to work in partnership with local communities in Tanzania to set up a center on eco-tourism (eco tourist activities, solidarity, partnerships). Pilot4dev has supported the presentation of a business plan, and has co-funded the website. It also offered support in creating communication links to support visitors. Despite positive feedbacks from the visitors, it has not been possible to sustain this activity for an extra year, as we lacked staff for the monitoring and did not collect enough funding.

**Evaluation of the H2020 MSCA grants:** This consisted in the evaluation of grants to be funded by the European research program MSCA (participation to the evaluation jury)

#### 4.2. Successful proposals-Running projects

The running projects are the following ones. The role of Pilot4dev will be specified.



#### **Support to the Grand Port Maritime de Guadeloupe to get the European label “Ecoports”**

Guadeloupe Port Caraïbes (GPC) a state-owned enterprise with five sites across the Guadeloupean archipelago. GPC is a multi-purpose harbor/port that handles a wide variety maritime traffic, from passenger and cargo ships. It welcomes 1 million passengers a year.

GPC manages maritime access and port facilities for all ports within its domain with a clear mission: to optimize the quality of Guadeloupe’s maritime access and promote trade between Guadeloupe and the Caribbean while reinforcing integration of the port within its environment.



The Grand port Maritime de Guadeloupe does more than just oversee ports, it is a major actor in the local economy, and serves as the island's principal logistics platform handling the import of fuel, raw materials, intermediate goods and many consumer goods, as well as the export of local production. Given its purview over vast tracts of land and water, GPC acts as environmental steward for its domain, with the responsibility of developing and managing its natural spaces.

With many environment and climate programs, the GPMG invested massively into climate mitigation (reduction of GHG emissions, renewable energy, waste management, research and development) and adaptation (restoration of eco-systems). This is why the GPMG decided to apply for the Ecoports label promoting quality standards of environmental protection, adapted to European Ports and Harbours.



The role of Pilot4Dev is to liaise between the Ecoports label requirements (the Ecoports headquarters are based in Brussels), and the GPMG, and to draft the application report including with the definition of indicators.

**Support to the Grand Port Maritime de Guadeloupe to develop their project LIFE RESILIENCE.**



In Guadeloupe, and in the Caribbean generally, the effects of climate change are already apparent:

- Increased intensity of severe weather events, such as hurricanes
- Rising sea levels and receding coastlines
- Increasing scarcity of resources

Together with Pilot4dev the GPMG is applying for EU LIFE funding for its Cáyoli program, which develops solutions with local stakeholders to strengthen resilience of maritime and coastal areas, the port, and the broader community.

### **Objectives**

- Preserve the living environment
- Protect economic activities

- Encourage development of local green jobs.



Under the LIFE Resilience project, the GPMG proposes to implement innovative solutions with strong potential for transferability and replicability in the Caribbean. This will encourage wide-scale restoration of three coastal ecosystems and diminish the effects of extreme climate events on the region and on its activities.

The LIFE Resilience project also reinforces research structures for drafting protocols for cultivation, production and transplant in a natural environment. Actions include:

- Scaling up nursery production of transplant specimens (coral cuttings, mangrove saplings, and seagrass meadows) for the restoration of natural areas.
- Building a network of specialists in the Caribbean focused on developing adaptation strategies to climate change.
- Restoring damaged high-priority natural areas.
- Proposing environmental restoration solutions suitable for public contracting authorities in Guadeloupe and the Caribbean
- Promoting the creation of a local environmental engineering industry.

### 4.3. Projects for which Decision is pending

#### **The LIFE Resilience project** (*This proposal has passed the first stage of the selection*)

Pilot4dev is a partner in the LIFE Resilience project described above. The role of Pilot4dev would be to support the project's implementation, and to give a more European dimension to the project. It is more in particular in charge of action E5 "project communication at the European level". The project has been submitted in September 2018. It has been shortlisted and the final decision is expected in April 2019.



**PILOT4 RESEARCH AND POLICY DIALOGUE Tanzania** (*This proposal has passed the first stage. Program: Lead Partner: TAPRI Tampere Peace Research Institute, Partners: Pilot4Dev, IMED, Institute of Management and entrepreneurship Development, and COWI (DK) for Best Dialogue (Tanzania).* The answer was expected early January but has been delayed due to the political context...

The project location is Tanzania. The duration of the project is 24 months. The global budget is 496 454 EUR and the co-funding is 90%. **The**

**global objective** of the project is to promote dialogue on economic, resources, policy and fiscal governance issues in Tanzania and to create a platform for sustainable dialogue including public and private stakeholders in different regions.

1. To promote and disseminate high quality and evidence-based research on policies, resources, economic and fiscal governance
2. To nurture debate among stakeholders from the public, private and civil society sectors, on economic and fiscal governance issues, especially with government stakeholders
3. To increase research capacity and expand the links, networks and connections among economic and governance research institutions in Tanzania

The project's overall objective of the project is to propose a long lasting and unique cooperation between cities and research centres in Europe and in Indonesia (and beyond), and to contribute substantially to sustainable integrated urban development, good governance, and climate adaptation/mitigation through long lasting partnerships, and tools such as sustainable local action plans, early warning tools and experts panels. The Specific objectives are:

**-To strengthen good governance:** continued promotion of good governance, and the necessary policy and legal frameworks to implement urban policies.

**-The sustainable use of resources by cities:** Climate mitigation and adaptation can be achieved by a better understanding of local resources, and the empowerment of the population to develop a local circular economy.

**-Social cohesiveness or Inclusive cities:** The project will pay a special attention to the question of informal settlements, rural migrants and marginalization.

**-Resilience and actions for the environment:** the project will support the transition to more resource efficient systems of production and consumption. It will develop early warning systems for the selected cities, an analysis of the main sources of pollution and develop unique innovative approaches.

**-Prosperity and Innovation in cities:** will be addressed with questions of innovation, culture, design, and the identification of sustainable financing mechanisms. **The**

**promotion of triangular cooperation:** will be developed with knowledge exchange and joint trainings among countries from the South (Indonesia, India, Malaysia, Nepal, Cambodia), and promote **the use/transfer of smart technologies.**

(2) to create Awareness raising campaigns against GBV (Gender Based Violence) including (HPG) harmful practices to girls, (3) to increase the capacities of CSOs in addressing Gender Based Violence (GBV).

### **4.4. Other initiatives**

Pilot4dev has applied to funding from different foundations: BMGF Misk Grand challenge on the promotion of SDGs, the Roi Beaudouin foundation, the Mercator


foundation etc. but it has been difficult to 1. To understand the requirements to apply to grants, and 2. To fit into the framework.

The DEAR proposal on the involvement of diasporas to create Awareness raising campaigns on Development, led by the African Diaspora Policy Centre in the Hague was equally rejected. We are looking for other opportunities to resubmit it.

The project Pilot4resilience was declared ineligible, and will be resubmitted in August 2019 with an extended partnership:

**Summary of the project Pilot4resilience:** Territories and communities need to build up their resilience or ability to withstand, recover and respond to a multiplicity of shocks and stresses linked to disasters such as climate extreme weather events, heat waves, terror or hybrid attacks. The vulnerability of territories and especially cities to climate- and destabilization related disasters can be shaped by risk perception, preparedness, cultural, demographic and economic characteristics of residents, and local governments' response among others. Territories lack a more people-centered preventive approach to disaster. Disaster risk reduction practices need to be multi-hazard and multisectoral, inclusive and accessible to be efficient. **URGENCY** Particularly at stake is the need to work with communities to adapt to a spiraling situation: disruptions in food, water or energy supplies in case of damages. These issues can be major threats to security and stability. By integrating a disaster management strategy and standardized approaches to be developed by the project, local governments can work on risks perception, prevention, recovery and resilience (UN Sendai Disaster Management Framework). **WHAT** The project will work on risks perception, and analysis (WP2 and 3), early warnings and preparedness (WP 4) While recognizing their leading, regulatory and coordination role, we will analyze how local Governments (urban and non-urban) could engage with relevant stakeholders, including communities in precarious conditions, or diasporas (WP 4 and 5), the community of practitioners in the implementation of policies, plans and standards (UN Sendai Disaster Management Framework). There is a need for the public and private sectors and civil society organizations, as well as academia and scientific and research institutions, to work more closely together and to

create opportunities for collaboration to integrate disaster risk into their management practices



#### Other Grant requests pending decisions:

- We will submit the 6<sup>th</sup> of May 2019 a grant requests to Brussel's international for the promotion of S.D.Gs and world citizenship in sensitive urban neighborhoods.

## V. NETWORKING AND ACHIEVEMENTS

Within only 18 months, Pilot4dev has developed a real network of people and organizations, able to implement projects jointly in different countries.

We actively participate regularly to European debates and events in Brussels including the events organized Think Tanks such as Friends of Europe, the German Marshall Fund of the United States, and WIIS: Women in International Security...

We develop regular contacts with the European institutions. The organization is registered in the Transparency Register of the European Union and has an access badge to the European Parliament.

In 2018/2019 have made contacts and presented our activities to several embassies in Brussels: the embassies for Norway, Canada, Colombia, China and Indonesia.

We relay messages of key decision makers on our blog (eg. The interviews of Cristina Gallach, former UN Secretary General ([link](#)), and Janez Potocnik former European Commissioner for the environment). [Link](#)

We have also taken contacts with the Brussel's region, the Brussel's Press Club, and Brussel's international.

We have presented the organization to different audiences for instance during the Green innovators forum in Brussels (March 2018)

By contributing to several European data bases, Pilot4dev also diversifies its expertise and missions.

Therefore, after only 18 months of existence, Pilot4dev demonstrates that it can achieve results with limited funding, by building partnerships, networking and sharing opportunities. The organization is also regularly promoting advocacy towards decision-makers for the future Climate, Security and Development policies.
